The Club understands that such a withdrawal of consent applies on a go-forward basis only and does not affect data that may have been integrated between RI and the Club Management Vendor when consent was current or not withdrawn.

4. The Club agrees that RI shall not be liable to the Club or its members (existing now or in the future), individually or collectively, for any damages of any kind whatsoever related to any of the Club Data the Club provides to RI

hereunder and the Club Data integrated between RI and the Club Management Vendor or for the Club's or Club Management Vendor's violations of any privacy or confidentiality laws or regulations, data breach or data theft.
